Fonds pour la faune nordique

The Fondation de la faune du Québec and the Société du Plan Nord partnered to create the *Fonds pour la faune nordique*, hereafter referred to as the "Fund". It is part of the 2020-2023 Nordic Action Plan to invest \$1 million to expand initiatives that develop and protect wildlife habitats in Northern Quebec.

The Fund will serve to finance projects initiated by Nordic organizations and communities north of the 49th parallel, the St. Lawrence River and the Gulf of St. Lawrence. Its purpose is to improve the quality and productivity of the habitats of harvested wildlife species. It will also serve to protect the habitats of wildlife species at risk, including threatened and vulnerable wildlife in northern Quebec.

Objectives

The purpose of the Fonds pour la faune nordique is to:

- > Increase support for concrete action taken for wildlife in northern Quebec;
- Encourage the participation of Nordic communities in the protection and enhancement of wildlife habitats:
- > Improve the quality and productivity of the habitats of harvested wildlife species;
- > Protect the habitat of wildlife species at risk, including threatened and vulnerable wildlife in northern Quebec;
- Develop new partnerships with local stakeholders and promote local sourcing of goods and services.

Fund eligibility criteria

In addition to the above objectives, project applicants must meet the following criteria:

Organizations	Any legally incorporated local or regional organization involved in the conservation, enhancement and development of wildlife habitats in northern Quebec. These include Nordic communities, municipal organizations and non-profit hunting, fishing and trapping associations.
Activities	 Habitat planning and development Plans and other initiatives to preserve habitats Knowledge transfer on means to protect and develop habitats
Examples of projects	 Improving the free movement of fish towards spawning or wintering grounds Restoring spawning grounds Restoring wetlands for waterfowl Maintaining suitable habitats in lakes for the Barrow's Goldeneye Safeguarding habitat for bats

To obtain funding from the *Fonds pour la faune nordique*, you must present your protect to one of the following programs:

- Amélioration de la qualité des habitats aquatiques (Aquatic habitat quality improvement)
 Project on the habitat of harvested aquatic wildlife (e.g., arctic char, brook trout, etc.)
- Faune en danger (Imperiled wildlife)
 Project on the habitat of a threatened or vulnerable species
 (e.g., Barrow's Goldeneye, prey birds, bats, etc.)
- AGIR pour la faune (Act for wildlife)
 Project on the habitat of any other species
 (e.g., waterfowl, fur-bearing animals, swallows, etc.)
